With vast experience in the oil and gas sector, Tom Hamilton is well positioned as the new Chairman of the Board of Directors for Methanex Corporation, the world's largest supplier of methanol.

For over 30 years, Mr. Hamilton has been involved in worldwide operations in the natural resources arena. His experience spans the areas of exploration, production, research, refining and marketing in the oil and gas industry.

He is currently co-owner of Medora Investments, LLC, a private investment company with a focus on energy, equities and real estate, which he formed in 2003. Prior to starting Medora Investments, Mr. Hamilton held a variety of executive management positions including those of chief executive officer and chairman of EEX Corporation (1997-2002); executive vice president at Pennzoil Company (1991-1997), during which he was also president of Pennzoil Exploration and Production Company (1995-1997); chief executive officer (1989-1991) and general manager (1988-1989) of the Frontier and International Operating Company of BP Exploration; senior vice president exploration at Standard Oil Company (1985-1988); executive vice president of global exploration and land for Aminoil Company (1982-1985) and multiple management positions with Exxon Corporation (1970-1982).

Mr. Hamilton also brings a wealth of knowledge from the numerous board positions he has held over the years. He joined Methanex's Board of Directors in 2007 and was actively involved in the Company's Corporate Governance, Responsible Care, and Audit, Finance & Risk committees.

He holds a B.Sc. degree (1965) and a distinguished alumni award (1998) from Capital University, as well as M.S. and PhD degrees (1967 and 1970, respectively) from the University of North Dakota. The University of North Dakota awarded Mr. Hamilton an honorary Doctor of Engineering degree in May 1993, elected him as a founding member of its School of Engineering and Mines Academy in 2003 and awarded him its highest alumni recognition, the Sioux Award, in 2007.

Mr. Hamilton holds memberships with the American Association of Petroleum Geologists, the Society of Exploration Geophysicists and the Society of Petroleum Engineers. He is also actively involved in civic activities, most notably in the area of mental health.
