

Methanex Company Backgrounder

The Global Leader in the production and supply of methanol. Methanex is a Vancouver-based, publicly traded company and the world's largest producer and supplier of methanol to major international markets.

Waterfront Shipping, Methanex's majority-owned subsidiary, is a global marine transportation company that plays a role in its integrated global supply chain, transporting approximately 85 per cent of the company's produced methanol to customers around the world. Waterfront Shipping is also a founding pioneer and key innovator in the use of methanol as an alternative marine fuel.

Quick Facts

- **Headquarters:** Methanex's head office is located in Vancouver, Canada.
- **Production Facilities:** Located in Canada, Chile, Egypt, the Netherlands (indefinitely idled), New Zealand, Trinidad and Tobago, and the United States.
- Sales Offices: Located across Asia Pacific, Europe, North America, South America and the Middle East.
- Employees: Methanex employs approximately 1,700 people globally.
- Revenue & Sales: With revenues in 2024 totalling ~US\$3.7 billion and sales volume of ~10.4 million tonnes.
- **Publicly Traded:** Methanex trades on the Toronto Stock Exchange in Canada under the symbol "MX" and on the NASDAQ Global Market under the symbol "MEOH".
- Company History: Methanex was incorporated in 1968 in Canada as Ocelot Industries. In 1982, Ocelot Industries established its first methanol plant in Kitimat, British Columbia. In 1992, the company was renamed Methanex Corporation.
- M&A: In June 2025, Methanex completed the acquisition of OCI Global's international methanol business.

Global Supply Chain

- Largest Methanol Tanker Fleet: Methanex manages a worldwide network of terminals and storage
 facilities and operates the largest methanol ocean tanker fleet in the world via its subsidiary, <u>Waterfront</u>
 Shipping.
- **Powered by Methanol:** Waterfront Shipping has been operating methanol-fueled ships since 2016, accumulating more than 245,000 operating hours while running on methanol. Approximately 60 per cent (19 vessels) of its operating fleet are methanol dual-fuel vessels.
